1. Information Collection and Use

a). Non-Personal Information Collected

It is crucial to highlight that we do not sell data to third parties. We may share information with third parties to enhance your user experience.

c). Device Information

We also collect behavioral data on how you and your device use our products. This includes, but is not limited to:

- (1) Device information comprises details such as the phone model, operating system version, language setting, nation, area, manufacturer, etc.
- (2) Details about our programs that you install, including the version and installation channel.
- (3) Information on your activity, including views, time spent in views, transitions between views, and how you enter and exit views.

The information gathered allows us to assess which features you enjoy and which require improvement. This information enables us to enhance our products and provide you with a better user experience. We encrypt all data before storing it locally or transmitting it to our systems for analysis. Aggregated data is only accessible to authorized individuals, and we frequently remove raw data relating to your transactions.

2. Data and Use

In general, we may only use non-personal information and informational data for internal purposes, such as alerting you of new goods or services and displaying advertisements for promotional and marketing reasons. We do not merge non-personal and personal information. We will not share your information with other parties for direct marketing reasons unless you expressly agree to such sharing.

3. Data Protection

To safeguard your information from unauthorized access, theft, alteration, or intentional harm, we have adopted widely utilized security methods such as data encryption, firewalls, and restricted access to our data centers.
